Additional Disclosures Required for Certain Entity Contributors

1. Each entity contributor must provide a list of its principal owners, partners, board members, officers, or, if no natural person exists in any such role, the name of at least one natural person who exercises control over the entity's activities.
2. *An entity that contributes \$25,000 or more in the aggregate to New Yorkers For A Better Future – Mayor 25, Inc. must complete and submit a Major Contributor form.
3. **LLC contributors must complete and provide Statement of Identity form.
4. *** Partnership contributors giving \$2,500 or more must provide a list of names and addresses for participating partners and attribution amounts.

Contribution Requirements:

- Federal and state law prohibit contributions from foreign nationals.
- Contributions are not tax deductible for federal income tax purposes.
- State law prohibits making a contribution in someone else's name, reimbursing someone for a contribution made in your name, being reimbursed for a contribution made in your name, or claiming to have made a contribution when a loan is made.
